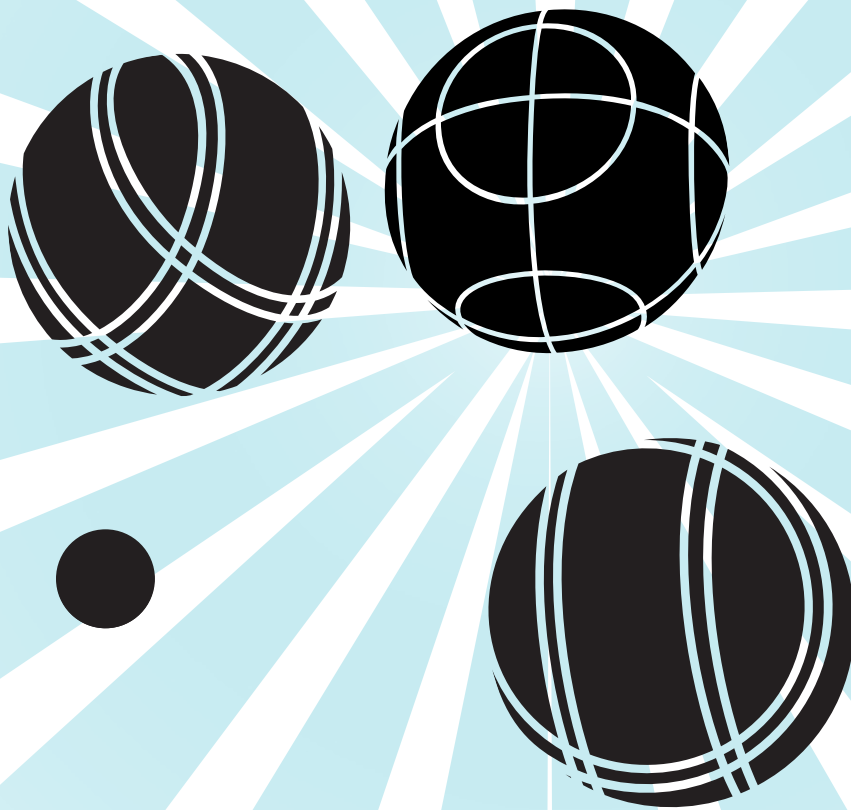

- Placement for **returning teams through Sept 6 are on a first come, first received basis.**
